INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF U3A SAFFRON WALDEN

Basis of independent examiner's report:

It also includes consideration of any unusual items or disclosures in the accounts, and the seeking of explanations from you as trustees concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the view given by the accounts.
